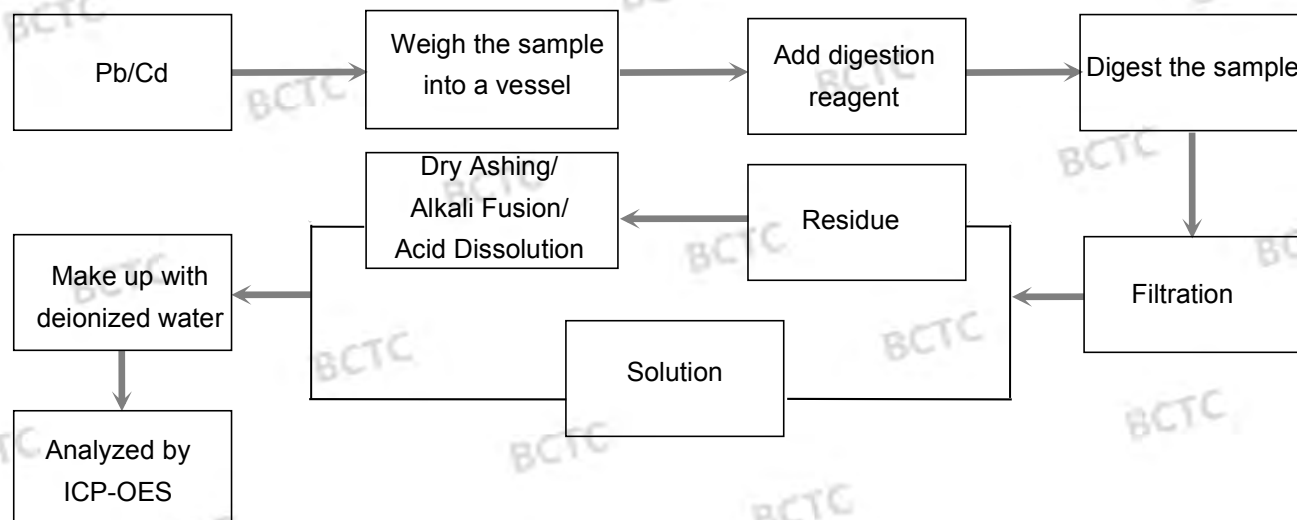

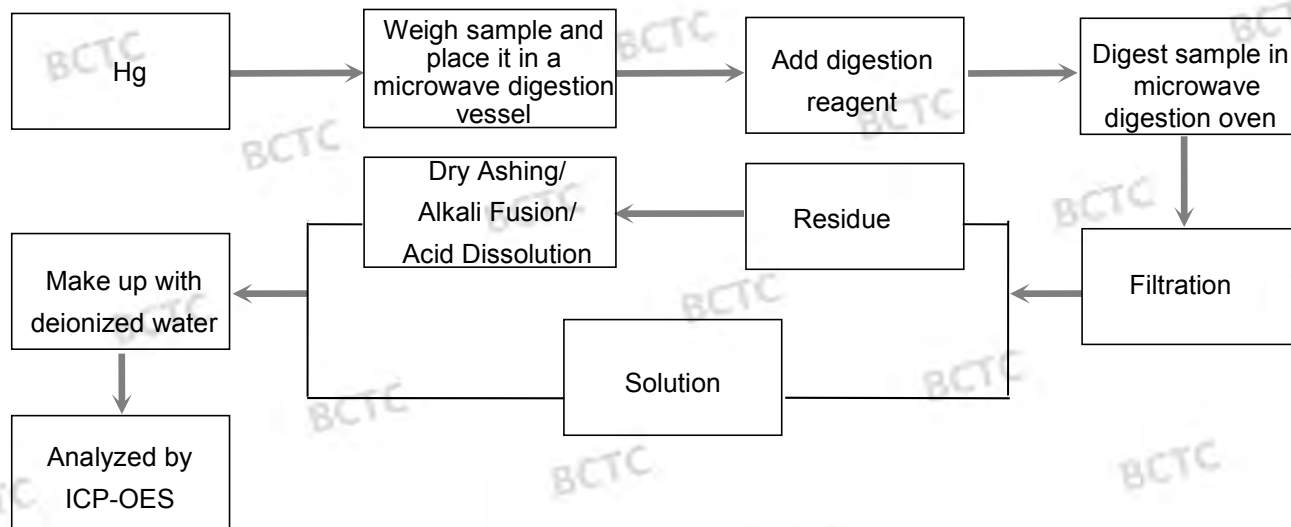

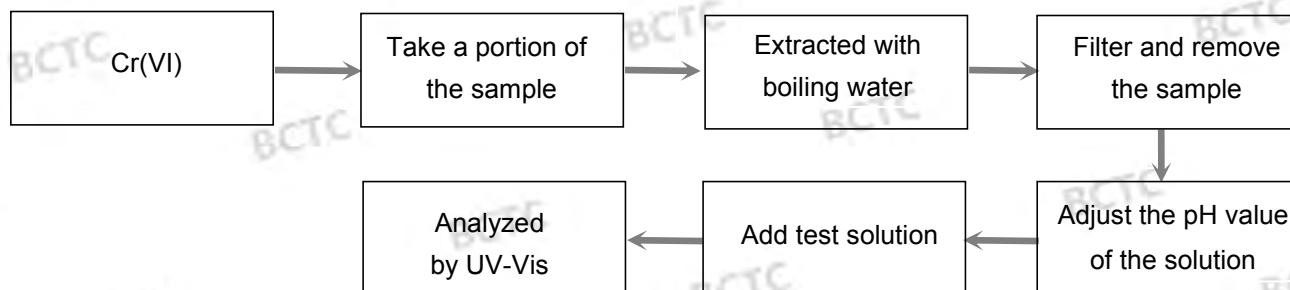

◆IEC 62321-7-1:2015 Ed.1.0



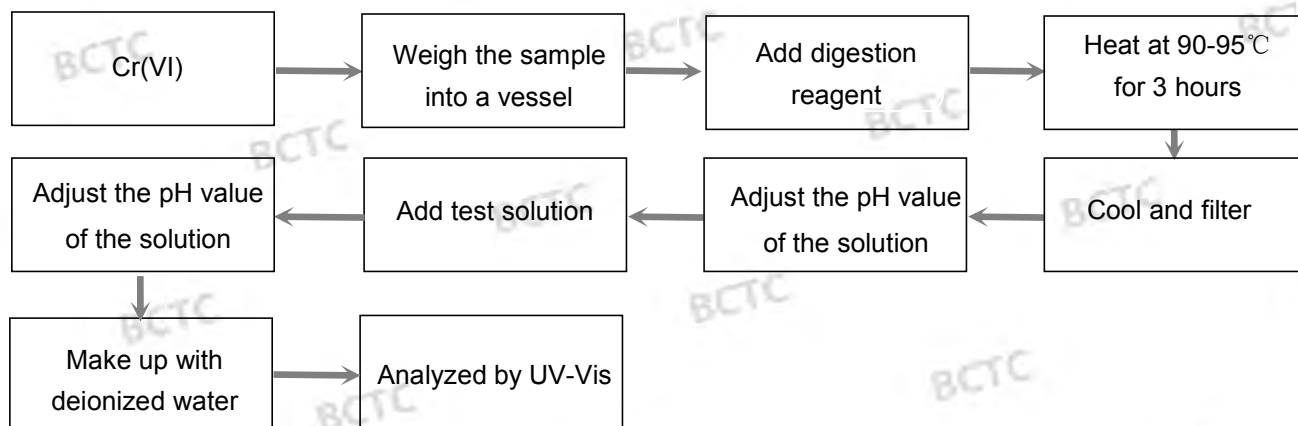

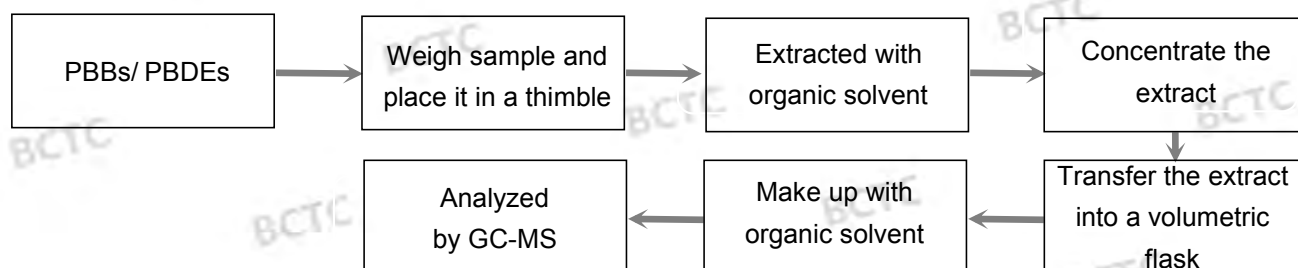

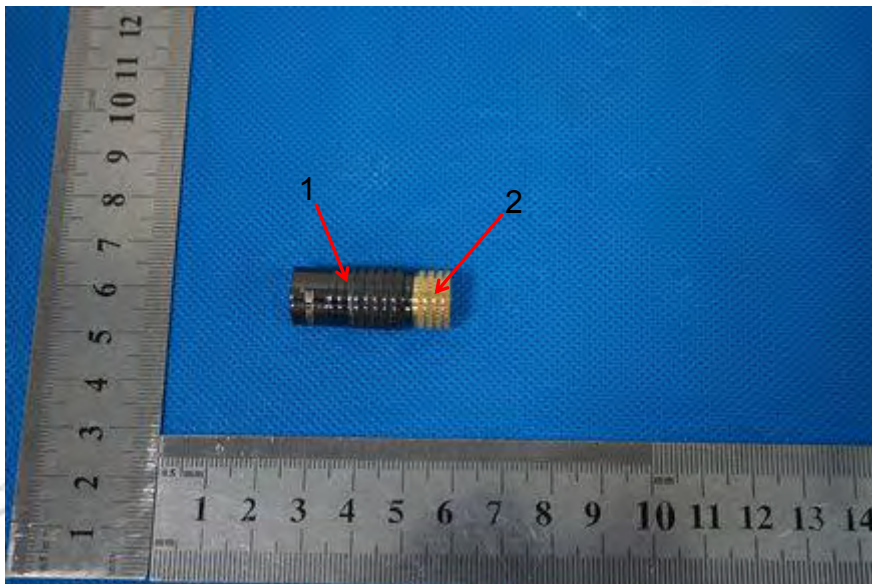

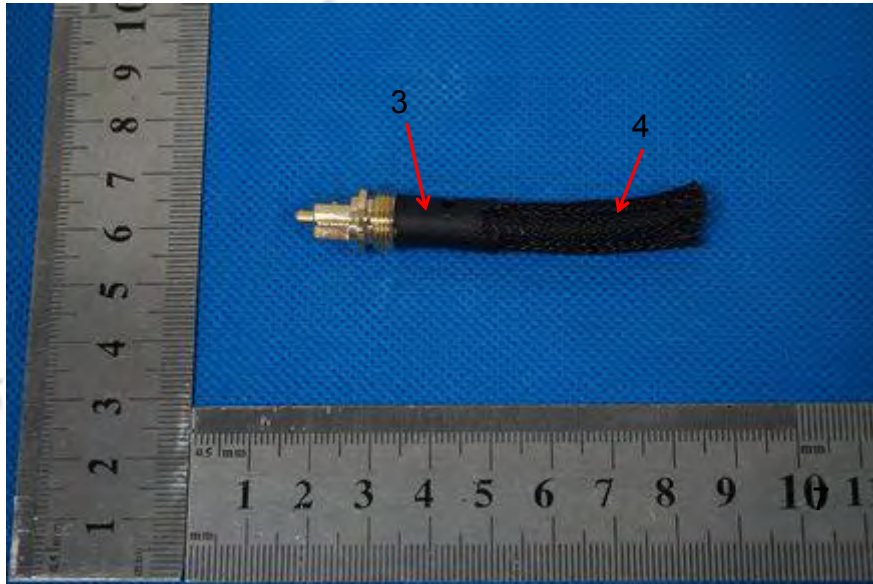
